Title: Taking a Behavioral Perspective on Shareholder Activism

Abstract: In this three-essay dissertation, I examine the consequences of shareholder activism to understand the dynamics of activism efforts and to explain the mechanism through which activism campaign influences the firm's performance. Chapter 1 provides an overview of the current literature and suggest a direction for new theoretical frameworks grounded in behavioral theory of the firm. Chapter 2 examines how managers of the targeted firms develop responses against the activist investor based on shareholders' reaction to the activism campaign launch; Chapter 3 focuses on the activist investors who joined the board of the target firm, and investigates the changing dynamics in the boardroom and the following consequences to the firm.
