TITLE: Examining the Impact of Shareholder Activism on The Targeted Firm Temporal Orientation and Resource Decisions (Proposal defended on June 22nd, 2021)

ABSTRACT: Prior research has established that activist investors precipitate substantial changes within the firm during the intervention, but current research largely overlooks the degree to which activist intervention impacts the targeted firms' fundamental strategic orientation. Focusing on the firm temporal orientation, I develop theory on how activism influences the targeted firms' time horizons both when attacked by activists and after the firm is relieved of activists' pressure. In my first empirical study, I examine how the relative motivation and capability of activist investors and managers influences the degree to which activist intervention shortens the targets firms' time horizons. In the second study, I propose that targeted firms shift their course of strategy once activist investors leave the firm, specifically by increasing their resource-consuming investments. Yet, because of the inherent temporal trade-off such investments present, I theorize that the degree of shift is likely affected by factors that shape leaders' future temporal depth. With my dissertation, I aim to contribute to streams of research on corporate governance, shareholder activism, and firm temporal orientation.
